Release and Waiver of Liability and Indemnity Agreement (Read Carefully Before Signing)

In consideration of being permitted to participate in, access, or use the martial arts equipment, classes, or activities in any way related to this agreement and/or enrollment form, the parent(s) and/or legal guardian(s) of the minor participant below agree:

1. The parent(s) and/or legal guardian(s) shall themselves inspect, and will instruct the minor participant that prior to participating in martial arts activities or events, he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe shall immediately advise the officials of such condition(s) and refuse to participate. I understand and agree that, if at any time, I feel anything to be UNSAFE, I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.
2. I/WE fully understand that:
 - (a) There are risks and dangers associated with participation in martial arts classes, events, and activities which could result in bodily injury, partial and/or total disability, paralysis, and death.
 - (b) The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe.
 - (c) These risks and dangers may be caused by the action, inaction, or negligence of the participant or the action, inaction, or negligence of others, including, but not limited to, the Releasees named and defined below.
 - (d) There may be other risks not known to us or that are not reasonably foreseeable at this time.
3. I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis, or death, however caused in whole or part by the negligence of the Releasees named below.

4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE the martial arts company used by the participant, including its owners, managers, promoters, lessees of premises used to conduct the martial arts event or program, premises and event inspectors, underwriters, consultants and others who give recommendations, directions, or instructions to engage in risk evaluation or loss, control activities regarding the martial arts facility or events held at such facility and each of them, their directors, officers, agents, and employees, herein referred to as "Releasee", FROM ALL LIABILITY TO THE UNDERSIGNED, my/our personal representatives, assigns, executors, heirs, and next of kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES, AND ANY CLAIMS OR DEMANDS THEREFORE ON ACCOUNT OF ANY INJURY, INCLUDING BUT NOT LIMITED TO THE DEATH OF THE PARTICIPANT OR DAMAGE TO PROPERTY, ARISING OUT OF OR RELATING TO THE EVENT(S) CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEE OR OTHERWISE.
5. I/WE HEREBY acknowledge that THE ACTIVITIES OF THE MARTIAL ARTS EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect.
7. On behalf of the participant individually, the undersigned parent(s) and/or legal guardian(s) for the minor participant executes this Waiver and Release. If, despite this release, the participant makes a claim against any of the Releasees, the parent(s) and/or legal guardian(s) will reimburse the Releasee for any money which they have paid to the participant, or on his behalf, and hold the Releasees harmless.
8. This Agreement is to be constructed in accordance with the laws of the State of Alabama with venue in the appropriate court of Baldwin County, Alabama.

9. If any payments under this agreement are not made within 7 days after the due date, or given at the next and most immediate class or event, such payment shall then be delinquent, and action at law may be brought against the participant, parent(s) and/or legal guardian(s) of the minor participant personally, and there shall be added to the amount of such payment the actual attorney's fees and all costs related to such action. In the event a judgment is obtained, such judgment shall include actual counsel fees and costs.
